

## **ADP Increases Cash Dividend; Marks 45th Consecutive Year of Dividend Increases**

ROSELAND, N.J., Nov. 12, 2019 /PRNewswire/ -- The board of directors of Automatic Data Processing, Inc. (Nasdaq: ADP) approved a \$0.12 increase in the quarterly cash dividend to an annual rate of \$3.64 per share, Carlos Rodriguez, ADP's president and chief executive officer, announced today.
